What was the Home Rule Day Rally?	<ul style="list-style-type: none"><li>● Event sponsored by Youth Organizations for Home Rule in D.C.</li><li>● 4,000 people</li><li>● 32 speakers</li></ul>
When did the Home Rule Day Rally take place?	<ul style="list-style-type: none"><li>● Home Rule Day Rally took place on July 17, 1966</li></ul>
Where did the Home Rule Day Rally take place?	<ul style="list-style-type: none"><li>● The Home Rule Day Rally took place on the National Mall.</li></ul>
Who was involved in the Home Rule Day Rally?	<ul style="list-style-type: none"><li>● Young supporters of Home Rule</li><li>● Civil rights activists</li><li>● Senators</li></ul>
Why did the Home Rule Rally of 1966 happen?	<ul style="list-style-type: none"><li>● The Home Rule Day Rally happened because people believed that by bringing awareness to the situation in Washington, they could solve the problem.</li></ul>
How did Home Rule Day Rally contribute to the D.C. Home Rule Act?	<ul style="list-style-type: none"><li>● The large number of people who attended the Home Rule Day Rally reflected how important Home Rule was to the entire community.</li><li>● If only 20 people had protested, it would have been unlikely that the issue would have captured any attention.</li><li>● Because the Home Rule Day Rally showed D.C.'s lack of representation to people outside of Washington, D.C., it helped the cause gain more support.</li></ul>
